Scientific employees are – provided that the allowed maximum duration of a temporary employment is not exceeded – generally employed for the initial duration of 3 years with the possibility of prolongation for additional two years.

The Faculty for Economics and Business Studies is going to launch two research clusters, namely “**Managing Dissolving Boundaries in a Digital Era**” and “**Behavioral and Social Finance & Accounting**”. With these clusters, we aim for path-breaking research with highest relevance for society. We will assign four of the eight positions to each research cluster. The State of Hessen also requires teaching of two hours per week for this position.

You have a completed academic university degree in the fields of business or economics or related disciplines, such as psychology, sociology, or mathematics/statistics. Furthermore, you should be interested in the fields of research of the respective cluster:
